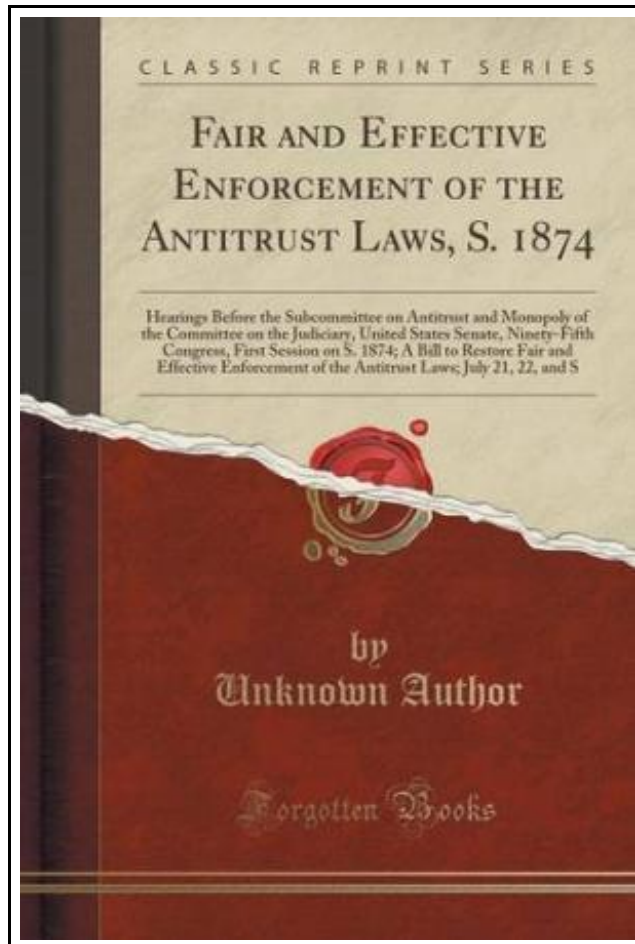

This bill will once again allow consumers the right to recover damages for antitrust violations which injure them. Consumers have always been the intended beneficiaries of the antitrust laws. The purpose of the antitrust laws, emphasized by both Congress and the Courts, has always been to provide consumers with better products and lower prices, to prevent suppliers singly or in combination from raising prices at the expense of individual citizens. It is conservatively estimated that price fixing and other antitrust violations cost American consumers more than \$150 billion a year. This cost is too often borne by persons who can least afford it. The exorbitantly high prices charged consumers as a result of antitrust violations do more than frustrate the economic goal of better products and lower prices. They frustrate as well basic human goals of fair and equitable treatment that are a fundamental part...
